**Overview****Graduation Rates 200 Overview**

Welcome to the IPEDS Graduation Rates 200 (GR200) survey component. **Data Reporting Reminders**

We would expect the number of exclusions in OM to be greater than or equal to the number of exclusions at 200% in GR200. Please review your data and make any necessary corrections or explain the discrepancy. (Error #2419)	Explanation	Yes	
Reason:	There are actually 3 exclusions, 2 students who actually were awarded a degree were accidentally count as an exclusion as well in the GRS for the 2009 cohort.
