Institutional Characteristics Overview

Reason	We amended the way we survey. Students living at home can come from multiple cities and not just Columbia. So we take into account a mile radius around Columbia that students commute from their parents' home. We then calculate an average number of trips to campus and incorporate mileage and car maintenance and parking pass into that figure.
